# Terms and conditions

- Only customers on the Vodacom network will qualify for this promotion.
- Participants must be at least 16 years of age.
- There are no additional charges to the customer for participating in the competition.
- For purposes of this competition, "Contract Customers" shall mean a Vodacom subscriber who has entered into an airtime agreement with Vodacom. "Prepaid Customer" shall mean a Vodacom subscriber who buys airtime in advance, by way of Top Up, voucher or recharge of airtime via electronic means.
- All Contract Customers who register as an m-pesa customer during this promotional period will receive R20 (Twenty Rand) cash into their m-pesa account. Payment of this amount will be made within 2 (Two) business days of the customer having registered.
- All Prepaid Customers who register as an m-pesa customer during the promotional period will receive R20 (Twenty Rand) free airtime and 20 (Twenty) free SMSs. Payment of this amount will be made within 2 (Two) business days of the customer having registered.
- Customers can only enter the competition once i.e: the date on which they register for Vodacom m-pesa and activate their account. No duplicate entries will be accepted.
- The promotional period shall run from 1 May 2011 to 31 October 2011.
- Only persons who register for Vodacom m-pesa and activate their account during this time period shall be eligible for entry into the competition. Only persons who have registered their SIM card by providing proof of their identity and residential address for purposes of RICA shall be eligible for entry into the competition after 30 June 2011.
- Persons shall only be eligible for the draw of R10 000 (Ten Thousand Rand) once, however all Participants who comply with the requirements for participation in the competition shall be entered into the draw for the weekly draw of R10 000 on a cumulative basis.
